

**NOTICE**

Subject: Petition filed by Adani Electricity Mumbai Limited (Generation Business) seeking review of the order dated 30.03.2020 passed by the Hon'ble Commission in Case No.298 of 2019.

- **-Case No. 105 of 2020**

The Petitioner Adani Electricity Mumbai Limited (Generation Business) has filed this Petition on 25.6.2020 under Section 94 (1)(f) of Electricity Act, 2003, read with Regulation 85 of Maharashtra Electricity Regulatory Commission (Conduct of Business) Regulations, 2004 to review order dated 30.03.2020 passed in Case No.298 of 2019.

The main prayers of the Petitioner are as under-

*(a) Admit the present Review Petition;*

*(b) Consider the actual Interest on Working Capital as submitted by the Petitioner for FY 2017-18 and FY 2018-19 instead of considering the actual Interest on Working Capital as "Nil" or "zero" while computing the efficiency gains on account of savings in Interest on Working Capital;*

*(c) Pass such order as this Hon'ble Commission may deem fit and proper in the facts and circumstances of the case.*
