Subject: New Petition, Petition filed by Kalika Steel Alloys Pvt Ltd. & Ors (27) seeking appropriate orders/directions pertaining to the Revision/ Change in Contract Demand / extension of the earlier orders in Case No. 82 of 2020..

- Application seeking permission to file Petition online and seeking urgent hearing for urgent reliefs
- **Case No. 137 of 2020**

The Petitioner Kalika Steel Alloys Pvt Ltd. & Ors (27) has filed this Petition on 6.5.2020 Petition under Section 57, 61, 86 and 181 of the Electricity Act 2003 seeking appropriate orders/directions pertaining to the Revision/ Change in Contract Demand / extension of the earlier orders in Case No. 82 of 2020..

The main prayers of the Petitioner are as under-

*a) To accept and admit the Petition through email and grant urgent hearing and issue orders for extending and modifying the provisions related to revision of Contract Demand.*

*b) That the Hon'ble Commission be pleased to:*

*i) The Petitioners humbly pray that the relaxation granted by the Hon'ble Commission vide Order dated 21 May 2020 in Petition No. 82 of 2020 for revision of Contract Demand be extended upto 31 March 2023.*

*ii) The Petitioners pray that the Hon'ble Commission be pleased to grant 1 day's relaxation in case the Petitioners are compelled to reduce their Contract Demand and the Petitioners may be permitted to reduce their C.D by notice of 2 days /48 Hrs instead of existing 3 days' Notice.*

*iii) The Petitioners pray that the Hon'ble Commission be pleased to extend the system of WEB SELF SERVICE(WSS)portal and make the same available to the Petitioners who intend to increase their Contract Demand even beyond the Original (Sanctioned) Contract Demand (CD before 22.03.2020) with the system of 7days advance application through WEB SELF SERVICE.*

*c) To pass appropriate directions as the facts and circumstances of the case demand and the Hon'ble MERC deem appropriate.*

*d) Copy of this petition has been served electronically through email to MSEDCL."*

The Petitioner has also file an Application for urgent hearing the prayers are as under:

- a) To accept and admit the Petition through email and grant urgent hearing and grant temporary interim reliefs.*
- b) To grant such other further reliefs as the facts and circumstances may require.*
