Subject: Petition of Cogeneration Association of India for increase the ceiling tariff of Rs 3.56/kWh kept by MSEDCL under tender no MSEDCL/RE/Bagasse/2019/75 Dated 27.12.2019 and to extend the bid submission date from 27.01.2020 by at least 2 month.

- **Case No. 27 of 2020**

The Petitioner Cogeneration Association of India has filed amended Petition on 29.5.2020 for increase the ceiling tariff of Rs 3.56/kWh kept by MSEDCL under tender no MSEDCL/RE/Bagasse/2019/75 Dated 27.12.2019 and to extend the bid submission date from 27.01.2020 by at least 2 month.

The main prayers of the Petitioner are as under-

*“By taking recourse to the powers conferred on this Honourable Commission for removal of difficulties under REGULATION 19 OF MERC (RENEWABLE PURCHASE OBLIGATIONS, ITS COMPLIANCE AND IMPLEMENTATION OF RENEWABLE ENERGY CERTIFICATE FRAMEWORK) REGULATIONS, 2019 and all other enabling powers available with this Honourable Commission, this Honourable Commission be pleased to approve the modality of procurement of power through MoU executed between the Cogeneration Projects for the balance period of their useful life, however, subject to the conditions and taking into consideration the points enumerated supra especially paragraph 7 and more particularly clauses ‘B’ [pertaining to rate] and ‘F’ [pertaining to tenure] set out herein above.”*
