The Petitioner Tata Power Company Limited - Distribution (TPC-D) has filed Petition on 3.9.2020 under Section 86 (1) (k) of the Electricity Act read with Regulation 92 and 94 of Maharashtra Electricity Regulatory Commission (Conduct of Business) Regulations, 2004 and all the enabling powers seeking approval for change in execution entity of 225 MW grid connected Wind-Solar Hybrid Power Projects from M/s Tata Power Green Energy Limited, a 100% subsidiary of The Tata Power Company Limited to M/s TP Saurya Limited, a 100% subsidiary of The Tata Power Company Limited..

The prayers are as under:

- a. *To approve the change in execution entity of 225 MW grid connected Wind-Solar Hybrid Power Projects from TPGEL to TP Saurya Limited.*
