The Tata Power Company Ltd has filed an Application on 13.6.2020 under Section 18 of the Electricity Act, 2003 and the MERC (Transmission Licence Conditions) Regulations, 2004 including amendments thereof, seeking amendment of the Transmission Licence No. 1 of 2014 dated 14.08.2014. Application for re-consideration of the amendment application and restoration of the proceedings in Case No. 137 of 2016 in accordance with the Judgement of the Hon'ble Supreme Court dated 03.04.2020 in Civil Appeal No.5049/2019 Hindustan Petroleum Corporation Limited Vs. Maharashtra Electricity Regulatory Commission & Ors.
