Subject:- Petition of SMW ISPAT Private Limited (Formerly known as Mahalaxmi TMT Pvt. Ltd). seeking Review of the Order dated 22.10.2020 passed by this Hon'ble Commission in Case No.175 OF 2017 under Section 94 of the Electricity Act, 2003
- read with Regulation 85 of the Maharashtra Electricity Regulatory Commission (Conduct of Business) Regulations, 2004.

The Petitioner SMW ISPAT Private Limited (Formerly known as Mahalaxmi TMT Pvt. Ltd). filed Petition on 20.11.2020 under Section 94 of the Electricity Act, 2003 read with Regulation 85 of the Maharashtra Electricity Regulatory Commission (Conduct of Business) Regulations, 2004. Limited seeking Review of the Order dated 22.10.2020 passed by this Hon'ble Commission in Case No.175 of 2017 under Section 94 of the Electricity Act, 2003 read with Regulation 85 of the Maharashtra Electricity Regulatory Commission (Conduct of Business) Regulations, 2004.

The prayer is as under:

- 1. To admit the present Petition and to dispose off the same on merit.
- 2. Hold and declare that the grounds raised herein are in favour of the Petitioner and against the Respondents.
- 3. To allow the Review Petition and set aside/ recall the impugned order dated 22.10.2020 passed by this Hon'ble Commission in case No. 175 of 2017 in directing/ allowing the 1<sup>st</sup> Respondent to levy Cross Subsidy Surcharge and other applicable charges on the Captive Users/ shareholders of Sai Wardha Power Generation Ltd. for FY 2016-17.
- 4. Hold that the 1<sup>st</sup> Respondent is not entitled to raise any bills pursuant to the Impugned order passed by this Hon'ble Commission;
- 5. To set aside the Impugned Bill, Annexure-1 hereto, issued by the 1<sup>st</sup> Respondent based on the Impugned Order;
- 6. Pending the hearing and final disposal of this Review Petition, to stay the operation, execution, implementation of the Impugned Order at least in respect of the Petitioner herein;
- 7. Pending the hearing and final disposal of this Review Petition, to stay the operation, execution, implementation of the Impugned Bill, Annexure-1 hereto, issued by the 1<sup>st</sup> Respondent.

- 8. Pending the hearing and final disposal of this Review Petition, the 1st Respondent be kindly restrained from taking any coercive action including the disconnection of power supply as mentioned in the impugned bill.
- 9. Pass such other and further orders as this Hon'ble Commission may deem fit and appropriate in the interest of natural justice.
- 10. Pass such further order in favour of the Petitioner herein as this Hon'ble Commission may deem fit and proper in the interest of equity, justice and good conscience.
