

**NOTICE**

Subject:- Petition of BFN Forgings Pvt. Ltd. (Formerly known as Bebitz Flanges Works Pvt. Ltd.) seeking Review of the Order dated 29.10.2020 passed by this Hon'ble Commission in Case No.170 of 2018 under Section 94 of the Electricity Act, 2003 read with Regulation 85 of the Maharashtra Electricity Regulatory Commission (Conduct of Business) Regulations, 2004.  
- **Case No. 223 of 2020**

The Petitioner BFN Forgings Pvt. Ltd. (Formerly known as Bebitz Flanges Works Pvt. Ltd.) filed Petition on 20.11.2020 under Section 94 of the Electricity Act, 2003 read with Regulation 85 of the Maharashtra Electricity Regulatory Commission (Conduct of Business) Regulations, 2004. Limited seeking Review of the Order dated 29.10.2020 passed by this Hon'ble Commission in Case No.170 of 2018 under Section 94 of the Electricity Act, 2003 read with Regulation 85 of the Maharashtra Electricity Regulatory Commission (Conduct of Business) Regulations, 2004.

The prayer is as under:

1. *To admit the present Petition and to dispose off the same on merit.*
2. *Hold and declare that the grounds raised herein are in favour of the Petitioner and against the Respondents.*
3. *To allow the Review Petition and set aside/ recall the impugned order dated 29.10.2020 passed by this Hon'ble Commission in case No. 170 of 2018 in directing/ allowing the 1st Respondent to levy Cross Subsidy Surcharge and other applicable charges on the Captive Users/ shareholders of Sai Wardha Power Generation Ltd. for FY 2017-18.*
4. *Hold that the 1st Respondent is not entitled to raise any bills pursuant to the Impugned order passed by this Hon'ble Commission;*
5. *To set aside the Impugned Bill, Annexure-1 hereto, issued by the 1st Respondent based on the Impugned Order;*
6. *Pending the hearing and final disposal of this Review Petition, to stay the operation, execution, implementation of the Impugned Order at least in respect of the Petitioner herein;*
7. *Pending the hearing and final disposal of this Review Petition, to stay the operation, execution, implementation of the Impugned Bill, Annexure-1 hereto, issued by the 1st Respondent.*

8. *Pending the hearing and final disposal of this Review Petition, the 1<sup>st</sup> Respondent be kindly restrained from taking any coercive action including the disconnection of power supply as mentioned in the impugned bill.*
  9. *Pass such other and further orders as this Hon'ble Commission may deem fit and appropriate in the interest of natural justice.*
  10. *Pass such further order in favour of the Petitioner herein as this Hon'ble Commission may deem fit and proper in the interest of equity, justice and good conscience.*
1. I am directed to communicate that the Petitioner is directed to implead Adani Electricity Mumbai Limited as Respondent and to immediately serve a copy of its above-mentioned Petition in soft copy to the Respondent and hard copy immediately after the lockdown is over and file acknowledgement to the office of the Commission thereafter.
  2. The Respondents are directed to submit the say with documents if any, in soft copy on the above –mentioned Petition immediately within 15 days with a copy to the Petitioner and on affidavit in 1+6 copies to the Commission immediately, after lockdown is over with a copy to the Petitioner.
  3. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
  4. I am directed to communicate that e-Hearing in this matter is scheduled on **Thursday, 26 November, 2020 at 10.30 am**. Kindly refer the Practice Directions dated 11 May 2020 and amended on 13 July, 2020 available on MERC website ([www.merc.gov.in](http://www.merc.gov.in)) for the protocol to be followed for and during the e-Hearing.
