Subject: Petition filed by Maharashtra State Electricity Distribution Co. Ltd seeking approval to scheme for creation of 400/220 KV switchyard at M/s GWEL under depository work for evacuation arrangement of MSEDCL share of 200 MW power and allowing recovery of expenditure thereof through ARR.

- **Case No. 215 of 2020**

The Petitioner Maharashtra State Electricity Distribution Co. Ltd has filed this Petition on 11.11.2020 under Section 94 (1) (g) of the Electricity Act, 2003, Regulation 92 of MERC (Conduct of Business) Regulations, 2004; and Regulation 106 of MERC (Multi Year Tariff) Regulations, 2019 seeking approval to scheme for creation of 400/220 KV switchyard at M/s GWEL under depository work for evacuation arrangement of MSEDCL share of 200 MW power and allowing recovery of expenditure thereof through ARR.

The main prayers of the Petitioner are as under-

- i. Admit the present petition.*
- ii. Approve scheme for creation of 400/220 KV switchyard at M/s GWEL for evacuation arrangement for MSEDCL share of 200 MW power from 2x300 MW Thermal power plant under depository work on the basis of the Cost to benefit.*
- iii. Approve DPR of scheme for creation of 400/220 KV switchyard at M/s GWEL for evacuation arrangement for MSEDCL share of 200 MW power from 2x300 MW Thermal power plant under depository work.*
- iv.. Approve expenditure of Rs. 153.69 Crores for above scheme for MSEDCL and allow to recover expenditure of Rs.153.69 Crores through ARR of MSEDCL*
- v. Pass any other orders as this Hon'ble Commission may deem fit in the interests of Justice.*
- vi. Condone error, omission if any, and give opportunity to rectify the same."*
