Petition seeking approval of supplementary agreements dated 11.12.2020

- **Case No. 232 of 2020**

The Petitioner Maharashtra State Electricity Distribution Co. Ltd. (MSEDCL) has filed Petition on 14.12.2020 under Section 86(1)(b) of the Electricity Act, 2003 read with Article 15.3 of the Power Purchase Agreements dated 22.04.2010 and 05.06.2010 Regulations 92, 93 and 94 of the MERC (Conduct of Business) Regulations, 2004

The prayer is as under:

- (a) *Admit the present Petition;*
- (b) *Conduct urgent hearing in the matter.*
- (c) *Approve the Supplementary PPA initialed on 11.12.2020 between the MSEDCL and RPL.*
- (d) *Pass the appropriate direction that revised Energy Charges to become applicable after suitable revision in MoD from the date of the Order passed by this Hon'ble Commission; AND/OR*
- (e) *pass any such other and further orders/directions as this Hon'ble Commission may deem fit and appropriate in the facts and circumstances of the case and in the interest of justice.”*
