Subject:- Petition filed by Adani Electricity Mumbai Limited seeking appropriate directions on account of the violation of the Hon'ble Commission's Order dated 12.06.2017 in Case Nos. 182 of 2014 & 40 of 2015 by Tata Power Company Limited.

And

Application for Interim relief.

Case No. 19 of 2021

The Petitioner Adani Electricity Mumbai Limited has filed the Petition along with Application for Interim relief on 2.3.2021 under Sections 142 and 146 of the Electricity Act, 2003 seeking appropriate directions on account of the violation of the Hon'ble Commission's Order dated 12.06.2017 in Case Nos. 182 of 2014 & 40 of 2015 by Tata Power Company Limited. and for wrongfully releasing (and in the process of releasing) a new connection to a consumer in a manner which not only defeats the intent and purpose, but also violates the governing framework for releasing new connections as laid down by the Hon'ble Commission in its dated 12.06.2017 passed in Case Nos. 182 of 2014 & 40 of 2015.

The main prayers are as under:-

- a) . Hold and declare that the new connection being released by TPC-D for EV Charging Stations at BEST's Shivaji Nagar Bus Depot falls under Scenario 53(a) as per Order dated 12/06/2017 passed by the Hon'ble Commission, in Case Nos. 182 of 2014 and 40 of 2015, and as a consequence, AEML-D alone has the right to develop the network to release the said connection:
- b) Direct the Respondent No. 1/TPC-D to roll-back/remove the distribution infrastructure built in violation of the order dated 12/06/2017 passed in Case Nos. 182 of 2014 and 40 of 2015, and further direct and hold that any cost associated with such illegal infrastructure will not be passed through in the tariff of TPC-D;
- c) issue appropriate directions against the Respondent No. 1/TPC-D or its officials under Sections 142 and 146 of the Electricity Act, 2003 for willful violation of the order dated 12/06/2017 passed by the Hon'ble Commission in Case Nos. 182 of 2014 and 40 of 2015; and
- d) pass any other Order as may be appropriate under the circumstances."

The prayers for Interim relief are as under:

- a) "Direct the Respondent No. 1/TPC-D to immediately stop and refrain from carrying out any further works for releasing power supply at the consumer location of Shivaji Nagar Depot of BEST till the pendency of the present case; and
- b) Pass such other and further order or orders as this Hon'ble Commission deems fit and proper under the facts and circumstances of the present case."
