DIRECT the respondents to release Principal Rs. 70,38,182.00 Rs Seventy lac thirty eight thousand one hundred eighty two only &LPS (Late Payment surcharge) for Rs 8,41,455/00 (Rs Eight Lakh Fourty one thousand four hundred Fifty five only)i.e. Total Rs78,79,637/00 (Rs Seventy Eight Lakh Seventy nine Thousand Six Hundred Thirty Seven only)in favour of the petitioner, on account of LPS on delay period as agreed rate of the PPA/s.
- 2. **Direct** the Respondents to remit the amounts due and payable on time in terms of the PPA;
- 3. **Direct** the Respondent to pay the costs of the present petition;
- 4. **Pass** such other further order(s) as the Hon'ble Commission may deem just in the facts of the present case."
