The Hon'ble Appellate Tribunal for Electricity (ATE)'s Judgment dated 27 April, 2021 in Appeal No. 319 of 2018 & IA No, 1534 of 2018, Appeal No. 288 of 2019 & IA No. 1997 of 2019, Appeal No. 377 of 2019 and Appeal No. 378 of 2019 filed by Roha Dychem Pvt. Ltd., Arvind Cotsyn(India) Ltd., Jsons Foundry Pvt. Ltd., and Western Precicast Pvt. Ltd. Challenging Commission's Orders in Case No. 119 of 2018, 19 of 2019, 119 of 2019 and 118 of 2019 .

APTEL has directed as under:
