Subject: Petition of Talegaon Floriculture Park Flower (Through Shri Malharrao Virchand Dhole, Secretary) for MSEDCL has changed the tariff classification of growers of the MIDC Floriculture Park, Talegaon, Dist. Pune from LT IV (B)-Agriculture-metered pumpsets to LT IV (C)-Agriculture-others as per their Commercial Circular dt 03/04/2020 and has discontinued Govt. subsidy. The classification of floriculture should be restored to LT IV (B) and the subsidy restored.

1.
