The Applicant Adani Electricity Mumbai Limited- Transmission has filed Application in Case No. 95 of 2021 (Petition of TPC – T under Section 39(2)(b) & (c) read with Section 86(1)(f) of the Electricity Act, 2003 read with Regulations 92 to 94 of MERC (Conduct of Business) Regulations, 2004 and applicable provisions of MERC (State Grid Code) Regulations, 2020 assailing the in-principle approval dated 06.08.2021 of the Capex Scheme of Respondent No. 2 i.e. Adani Electricity Mumbai Ltd.- Transmission for installation of 220/33 kV Sub-stations with 2 x 125 MVA Power Transformers at Bandra Kurla Complex, Mumbai The Hon'ble Commission vide the said Capex approval has approved the cost of Rs. 1093.91 Crores (against AEML-T's claims of Rs. 1213.03 Crores) for creation of the AEML Substation.)
