Subject: Petition of The Tata Power Company Limited – Distribution Business seeking declaration from this Hon’ble Commission that the letters dated 08.10.2020 and 09.12.2020 issued by the Maharashtra State Electricity Transmission Company Limited (STU) regarding grant of grid connectivity to its Extra High Voltage consumers wherein Maharashtra State Electricity Transmission Company Limited (STU) has approved connectivity of Extra High Voltage consumers directly to the intra-state transmission network without any intervening Distribution System, are contrary to the provisions of the Electricity Act, 2003 and without following the procedure contemplated under the State Grid Code.

- **Case No. 68 of 2021**
