Subject: Petition of Ghodawat Energy Private Limited & Ors. under Section 142, 146 and 149 of the Electricity Act, 2003 seeking action against MSEDCL for blatant violation and non-compliance with the mandatory provisions of Regulations Governing Open Access regarding purchase of over-injected units.
