Subject: Petitioner of Green Infra Wind Energy Projects Ltd. under Sections 86 (1) (e), 86 (1) (f) and 142 of the Electricity Act, 2003 for directions to the Respondent, Maharashtra State Electricity Distribution Company Limited, to perform its obligations under the Energy Purchase Agreements executed with the Petitioners for purchase of energy generated from the Petitioners' wind power projects situated in the State of Maharashtra and to initiate proceedings against the Respondent for non-compliance of the provisions of the Electricity Act, 2003, the MERC (Terms and Conditions for Determination of RE Tariff) Regulations, 2010, the MERC (Renewable Purchase Obligation, its Compliance And Implementation of RFC Framework) Regulations, 2010, the Suo-Motu Orders for the Determination of Generic Tariff for the Renewable Sources of Energy dated 22.03.2013 in Case No. 6 of 2013, and the MYT/ARR Order dated 30.03.2020 in Case No. 322 of 2019.

1.
