Subject: Petitioner of ReNew Wind Energy (Varekarwadi) Private Limited under Sections 86 (1) (e), 86 (1) (f) and 142 of the EA, 2003 for directions to the Respondent, MSEDCL, to perform its obligations under the EPA executed with the Petitioner for purchase of energy generated from the Petitioners wind power projects situated in the State of Maharashtra and to initiate proceedings against the Respondent for non-compliance of the provisions of the EA, 2003, the MERC (Terms and Conditions for Determination of RE Tariff) Regulations, 2010, the MERC (RPO, its Compliance and Implementation of RFC Framework) Regulations, 2010, the Suo-Motu Orders for the Determination of Generic Tariff for the Renewable Sources of Energy dated 22.03.2013 in Case No. 6 of 2013 dated and the MYT/ARR Order dated 30.03.2020 in Case No. 322 of 2019.
