Subject: Petition of RattanIndia Power Limited (RIPL) under Section 86 of the Electricity Act, 2003 imploring this Hon'ble Commission to intervene in the current coal crisis being faced in India and to issue necessary directions to the Respondent i.e., Maharashtra State Electricity Distribution Company Ltd. enabling the Petitioner to sustain its generation and meet the power demand of the State of Maharashtra.
