Subject: Petition of Kharghar Vikhroli Transmission Private Limited under Section 86 (1) (a), (c) & (f) and other applicable provisions of the Electricity Act, 2003 read with Article 12 of the Transmission Service Agreement dated 14.08.2019 seeking, inter-alia, compensation/ relief for increased cost of Project during Construction Period due to the 'Change in Law' event being increase in Acquisition Price.
