Subject: Petition of Maharashtra State Electricity Distribution Company Limited (MSEDCL) under Section 63 of the Electricity Act, 2003 for adoption of the tariff discovered through the competitive bidding process held for long term procurement of 15.85 MW wind power from the wind generators whose EPAS with MSEDCL have expired.
