Subject: Petition of Nature International Private Limited under the provisions of the Electricity Act, 2003 and more particularly Sections 86(1)(e), 86(1)(f), 86(1)(k), of the Electricity Act, 2003, seeking appropriate relief on account of change in law as provided under Power Purchase Agreement dated September 30, 2020 due to the increase in goods and service tax rates on solar panels/modules and increase in custom duty on solar inverter.
