Subject: Petition of Kharghar Vikhroli Transmission Limited (Formerly known as Kharghar Vikhroli Transmission Private Limited) under Section 86 (1) (c) & (f) and other applicable provisions of the Electricity Act, 2003 read with Articles 3, 4 and 11 of the Transmission Service Agreement dated 14.08.2019 seeking, inter-alia, extension of Scheduled Commercial Operation Date due to Force Majeure events.
