Subject: Petition of Mayura Steels Pvt. Ltd. seeking implementation of Regulation 3, 7, 9 and 10 of the MERC (Renewable Purchase Obligation, Its Compliance and Implementation of Renewable Energy Certificate Framework) Regulations, 2010 W.R.T following the procedures envisaged therein and pay for the power which has already been Accounted towards RPO and under Section 86 (1) (e) of the Electricity Act, 2003 seeking directions to MSEDCL for payment of power w.e.f 25.03.2012 till 06.06.2018 since the power injected by the petitioner was injected on the basis of assuance of a long-term EPA.
